



# DOA( HKAR – 21)Training Course

The 2-day course will discuss in general terms the legal and regulatory system in Hong Kong. The instructors will address the HKAR-21 DOA (all paragraphs), AMC and GM in details and guide through design organisation approval process and under which conditions an approval will be issued by HKCAD. During the first day of the training course, DOA concept and legal background, evolution of DOA, HKAR-21 Subpart J - Design Organisation Approval requirements, AMC and GM will be presented. On the second day, two examples of the content of the Design Organisation Handbook will be shown for clarification and better understanding on how to draft such a handbook. This second day will be finished by a presentation of the application process and working procedures for DOA, explaining the initial investigation, surveillance and approval of significant changes to the DOA.
