



# Basic HKAR-21 Training Course

The 2-day course will discuss in general terms the legal and regulatory system in Hong Kong. The instructors will address the HKAR-21 Requirements, AMC and GM in general and walk through design approval process and under which conditions a Type Certificate, a supplemental Type Certificate and an HTSO Authorisation will be issued by HKCAD. Also the classification of changes and repairs will be explained and under which conditions changes and repairs are approved by HKCAD or alternatively approved by an approved Design Organisation. The conditions under which HKCAD shall issue the Certificates of Airworthiness, Noise Certificates and Production Approvals will be explained too. At the end of the training course the attendees should have a general understanding of HKAR-21.
